The Board of Education will convene into Closed Session, to 1) **specifically to discuss employment of a public employee**, as per Wisconsin Statute 19.85(1)(c) “considering employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility.” and 2) **specifically to review visitor protocols** as per Wisconsin Statute 19.85(1)(d) “Except as provided in s.304.06(1) (eg) and by rule promulgated under s. 304.06 (1) (em), considering specific applications of probation, extended supervision or parole, or considering strategy for crime detection or prevention.

Board of Education will reconvene into open session and may take action on things discussed in closed session

In accordance with the intent of Wisconsin’s Open Meetings Law, the Board will not discuss or take action on matters during this Citizens’ Forum period. Any and all opportunity for public comment within a board meeting is provided by and subject to Board Policy 0167.3, Public Comment at Board meetings. The meeting Chair is responsible for maintaining order at the meeting and ensuring the Board is able to conduct its official business for the District. Therefore, the Chair may provide a variety of instructions regarding the conduct of the meeting, and everyone is expected to abide by those instructions. This includes but is not limited to enforcing the 2-minute time limit on comments per speaker, limiting the number of total speakers, or other actions.
