Foundation History

The Foundation is governed by a volunteer Board of Directors that operate independently of the School Board. The Foundation Board is supportive of the excellence that has always highlighted the school district.

It is the long-range goal of the Foundation Board of Directors to build the Foundation into a self perpetuating endowment fund. By investing all contributions, the Foundation Board can make awards from the interest earned. As the Foundation grows, so does the Board's grant-making capabilities.

Who Has Benefited?

Last year the Foundation awarded 60 student scholarships totaling \$27,250.

How Can You Help?

- 1. **Cash** Cash gifts qualify as a charitable contribution for federal income tax purposes and are deductible up to 60% of the donor's adjusted gross income.
- 2. Stocks and Bonds Gifts of stocks and bonds avoid capital gains and allow for a full deductions for the appreciated value up to 30% of the donor's adjusted gross income.
- **3. Real Estate** Current tax deduction for full fair market value and avoidance of capital gains. In addition, the donor may retain the right to reside on property donated.
- **4. Life Insurance** Donors may gift a policy, assign the dividends as a contribution, or name the Foundation as a beneficiary.
- Bequests Through a will, donors can gift cash, stock, property or real estate. A gift in trust can be offered to benefit family members during their lives.
- 6. Charitable Trust Charitable trusts, or deferred gifts, generally include a transfer of assets to the Foundation in return for a lifetime income for the donor, a spouse, children or a friend. In addition, the donor is eligible for a tax deduction.
